EUROPEP

What?

The EUROPEP instrument is a 23-item validated and internationally standardized measure of patient evaluations of general practice care.

Impact

The instrument has been used in about 20 countries and is available in Dutch, Danish, English, French, German, Hebrew, Italian, Norwegian, Portuguese, Swedish, Slovene, and Turkish etc.

The European Practice Assessment (EPA)

What?

The EPA instrument is an internationally standardized and validated instrument for assessing practice management in primary care practices

The EPA indicators have been developed in an international study (2001-2004). It was developed by an internation group of primary care researchers - linked to EQuiP - and the Bertelsmann Foundation in Germany.

Impact

The national implementation of EPA lies within the responsibility of the individual countries. During the pilot study 50 practices were included for each country. Since the pilot study, EPA was used in the following countries: Belgium, Germany, Netherlands, Slovenia, and Switzerland.

Furthermore Romania as a new country has started a pilot study using EPA and several more new countries already made plans of implementation, e.g. Saudi Arabia and Qatar.



The International Family Practice **Maturity Matrix (IFPMM)**

What?

The IFPMM is an organisational assessment aimed at stimulating practice-led quality improvement in primary care. It is a method to facilitate organisational development using group-based formative assessment and benchmarking.

Impact

It had been translated and tested in the following countries: Albania, Belgium, Croatia, France, Germany, Greece, Italy, Kosovo, Nigeria, Norway, Portugal, Slovenia, Spain, Sweden, Switzerland, The Netherlands, Turkey, and United Kingdom.



PECC-WE: Patient Empowerment in **Chronic Conditions - WONCA Europe**

What?

PECC-WE aims to improve the quality of patient care by developing evidence based education and training for European GPs and Practice Nurses so that they can effectively and efficiently empower patients to improve their own self management of chronic conditions (noncommunicable disease) in the context of general practice/primary care.

597 doctors evaluated the survey, 449 took the English e-course and 148 used the German tool:

• 99% stated that the e-course helped to improve their skills and competences.

• 97% found that the course motivated them to learn and reflect

upon the topic. • 88% found that skills obtained from the e-course were applicable in practice.
